- b. **Article 3:** Does not have to be a parent of an EL but may not be an employee of the district in order to vote
 - i. Section 1
 - 1. ELAC/School Site Council sends one person per site to DELAC
 - 2. District sends one designee and gets a vote
 - ii. Sections 2: Term of Office
 - 1. Participate 1 school year (4 meetings)
 - iii. Section 3: Termination
 - 1. Written form please
