- 8 State Priorities: Basic Services (materials/facilities), Standards Implementation, Course Access, Student Achievement, Other Student Outcomes, Parent Involvement, Student Engagement, School Climate
- SBA is ONE item represented on Dashboard
  - Target: Blue & Green on Dashboard is goal
