  - a. Review the new Learning Continuity Plan (LCP)
  - b. The 2019-2020 DELAC Committee was convened in August to review the LCP components, actions and proposed expenditures enacted by Senate Bill 98 to balance the needs of all stakeholders: educators, parents, students and community members due to the impact of COVID-19. The DELAC Committee is an important governing board/stakeholder group engaged in discussion and provided the following guidance and Feedback:

### Continuity of Learning

- Employee Jobs - Job duties will be modified to help with COVID responsibilities (temp checks, etc.)
- Schedule Clarification - teachers work full days, students have modified instructional days in Hybrid and Mandated Distance Learning
- Mesa View - reclassification of students that have been in the US since birth and have not passed the ELPAC assessment or have but not been reclassified. Lorena - LTELs at Mesa need additional attention
- After School/Homework Help – How is support allocated in all schools and what if they don't speak English? - Support and communication is provide in various languages at all

## **Learning Loss, Emotional Well Being, Pupil Engagement and Outreach**

- Enedina- How will we know if kids are reading or not? i-Ready is a diagnostic assessment that will help assess students for reading, assigns a Lexile, reading logs, RI will be available to support, however, in order to meet individual needs teachers will work with students in small groups and tailor instruction to meet individual needs.
- How will students get books? - eBooks from HBPL, our own eBooks library in OVSD coming soon; In-person Hybrid model: check out online with in-class delivery
- ELPAC Summative – yes, it slated to be given in spring.

## **School Nutrition, Increased or Improved Services, Review & Adoption Timeline**

- Homework help, emotional issues - Will students get help and HOW do they seek help? Front lines are the teachers, they may help guide the next steps. Every site has access to bilingual translation, SPED teachers, Nurses, Social workers/psychologists, etc.
- Provide Parents with - “How To” connections links, books, resources
- Videos provided - SEL videos on how to deal with COVID would be a nice addition to our website regarding the latest COVID information (Torrance USD example)
- Virtual Academy Signature - must have a student signature? How do we force it? What if they don’t want to sign? Will they still be able to “attend” school?
