### NEW BUSINESS

#### Part 1: Reclassification

- Must get overall level of 4 on ELPAC
- Multiple criteria - Must meet grades across the board
- Awards are given to students who reclassify to recognize this amazing achievement!

## **Part 2: Consolidated Application (2020-2021)**

- Title I: Addresses the needs of socioeconomically disadvantaged.
- Title II: Professional development for teachers, recruitment of highly qualified teachers and principals.
- Title III: Supplementary programs for English Learners and Newcomers.
- Title IV: Funds for student support and academic enrichments. Authorizes activities in three areas: well-rounded education, safe and healthy students, technology.
  - Q: If Westmont is Title 1 & VAPA do they get funding support from both funds? Yes, they may receive funds from both sources: Title 1 & Title IV.
  - Title IV: Is based on need, innovative programs, etc., NOT based on equal amounts divided up for each school

## **Part 3: LCAP 2021-2024 Goals, Actions & DELAC Final Review**

- AB86 Grant Funding: There are new additional one time state funds available. New In-Person Instruction grant funds (\$2,275,679) are designated to get kids back safely on campus.
- Extended Learning Opportunity funds (\$5,256,304) will be used to support LCAP Goals and programs such as our summer learning acceleration to help close the achievement gap
  - Plan addresses topics such as extending instructional time, closing learning gaps, integrated pupil support, community learning hubs, additional academic support, staff training, paraprofessionals, etc.
- How we spend the monies above should be based on our 3 Goals: Pupil Outcomes & Conditions of Learning, Targeted Supports to increase achievement, and stakeholder engagement.
- Next Steps: LCAP was presented at the May 11 board meeting and will be presented for Board approval by June 22. Then, each school site will align their school site goals (SPSA), actions, and funding expenditures to meet align with the district LCAP goals.
